A Reminder for Parents

SNOW & EXTREME WEATHER POLICY

Policy Statement

It is our policy for Boomerang Kids to remain open during snow or inclement weather conditions. Closure of the setting is an extreme measure and would not be taken lightly.

There will be no refunds on fees.

It is expected that all staff make reasonable and appropriate attempts to get to setting. Walking for up to 2.5 miles is considered appropriate in almost all circumstances. For those coming on longer journeys every attempt should be made to catch public transport (if running) if driving is not possible. A skeleton staff will be in operation.

The setting will close at 3:30pm, due to safety, to ensure that both children/parents and staff can travel home in natural light, due to snow and ice.

It will be the decision of the Manager or Deputy Manager to make the decision as to whether to close the setting earlier, due to the weather changes or if it is deemed unsafe for staff to travel back to their homes.

Communication

Effective communication with parents is paramount and the following procedures will occur wherever possible whenever snow is clearly forecast or falls:

- An email will be sent to all parents/carers (please ensure we have your correct email address). Also a message will be sent using 'Tapestry'.
- Please check on our social media pages for notifications if the setting does not open.
- A member of staff will inform parent/carer at the time of 'sign-in' as to whether the setting will remain open the f
- ull session (informing time of closure).



FINANCE MATTERS

GRACE PERIOD

Please be aware:

If you are claiming the **Extended Entitlement 30-hour Funding** that the government allow a **'grace period'** so that if your circumstances change, i.e. you leave your job, you still have time to make other arrangements and also fulfil contractual obligations to cover notice periods.

Please ask Fiona to check when your 'grace period' ends as this may affect your decision to make any immediate changes to your child's nursery attendance.

30 HOURS DON'T FORGET TO REVALIDATE YOUR CODE!

Families should receive email or text reminders from the childcare service to **reconfirm their codes**. Please respond promptly to these reminders.

Boomerang Kids will also continue to issue alerts through our newsletters, noticeboards and website so please log on to your childcare account to re-validate.

Please note: if your invoice shows a total amount in brackets this means your account is in credit and there is nothing further to pay.

FUNDED CHILDREN ALL ABSENCES INCL. HOLIDAYS

It is very important that **children using FUNDED hours** inform us of any absence as this will be audited by the Early Years Team at Brighton Council.

The Early Years Team want to ensure that free education places are used to their full potential, which is why we are asked to keep up-to-date records of <u>all</u> child absences.

If the absences total more than 10 days a term we are required to inform them and this then becomes a matter for further investigation and is essentially taken out of our hands.

NON PAYMENT OF FEES OR FEES OWED

Boomerang Kids is a charitable, nonprofit making nursery and, as such, is reliant on the timely payment of nursery fees. Our policy states that if fees are owed and remain outstanding we may ask you to keep your child at home **until the fees have been paid in full**.

It is very important that you keep us informed if you are having any problems making payments as we can employ a number of strategies including setting up a Payment Plan.
